EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A SERVICE AND MAINTENANCE AGREEMENT WITH THE METCARE BIOMEDICAL CORPORATION FOR THE INSPECTION, PREVENTIVE MAINTENANCE AND CALIBRATION OF MEDICAL EQUIPMENT IN THE DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL, NTRA, TAUGTOG, BOTOLAN, ZAMBALES

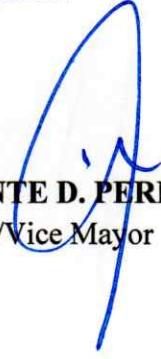
