**RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR OF BOTOLAN, ZAMBALES, TO SIGN, ENDORSE LOAN DOCUMENTS, NOTES AND OTHER DOCUMENTS PERTAINING TO THE LOAN TO BE OBTAINED FROM THE LANDBANK OF THE PHILIPPINES**

**Whereas**, Section 22c of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned;

**Whereas**, the Municipal Government of Botolan aims to accelerate local economic growth, improve public services, and enhance infrastructure development to better serve the constituent community;

**Whereas**, to finance the implementation of various priority local infrastructure projects, the Municipal Government intends to secure a loan facility from the Landbank of the Philippines (LBP) in the aggregate amount of two hundred twenty million seven hundred one thousand pesos (P220,701,000.00);

**Resolved, as it is hereby resolved** to authorize Hon. Jun Omar C. 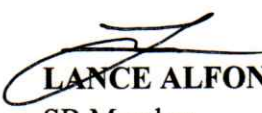

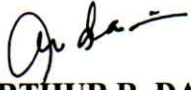
