RESOLUTION APPROVING THE ANNUAL BUDGET OF THE SANGGUNIANG KABATAAN OF BARANGAY BURGOS, MUNICIPALITY OF BOTOLAN, ZAMBALES FOR FISCAL YEAR 2025 IN THE AMOUNT OF FOUR HUNDRED EIGHT THOUSAND AND NINETEEN PESOS (P408,019.00)

Whereas, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is mandated to review and approve the annual budget of component barangays to ensure that the same are in conformity with existing laws, rules and regulations;

Whereas, the Sangguniang Kabataan of Barangay Burgos has duly enacted Annual Budget for Fiscal Year 2026 and submitted the same to the Sangguniang Bayan for review and approval;

Whereas, the proposed Annual Budget for Fiscal Year 2026 of Sangguniang Kabataan of Barangay Burgos amounts **Four Hundred Eight Thousand and Nineteen Pesos (P408,019.00)** to covering the estimated income and programmed appropriations for the effective delivery of basic services and implementation of development programs, projects, and activities of the barangay;

Whereas, after careful review, the proposed utilization of funds of Sangguniang Kabataan of Barangay Burgos for Fiscal Year 2026 was found to be in accordance with the provisions of the Local Government Code of 1991, applicable budgeting laws, rules and regulations;

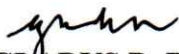
Now therefore, on motion of Hon. Atty Edmund Dante D. Perez, seconded by Hon. Eddie D. Daos, and approved by all the members, be it;

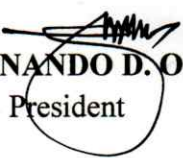

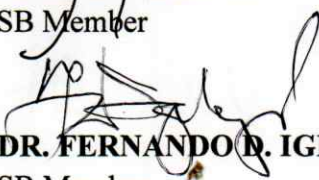

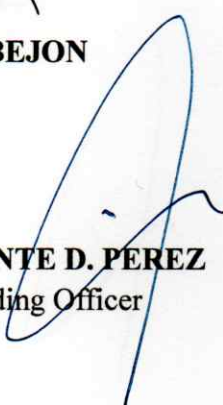
