RESOLUTION NO. 108-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, AND MS. MARY DESILOU M. ACADEMIA, ACTING MUNICIPAL TREASURER, TO OPEN A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR ECO-TOURISM FEES AT THE LANDBANK OF THE PHILIPPINES-IBA BRANCH, IBA, ZAMBALES AND TO SERVE AS AUTHORIZED SIGNATORIES THEREFOR

Whereas, Section 313 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to establish and maintain Special Accounts in the General Fund (SAGF) for specific receipts derived from public utilities, economic enterprises, and other special levies/fees;

Whereas, the Municipality of Botolan collects eco-tourism fees intended to fund the development, regulation, preservation and promotion of local eco-tourism sites and environmental initiatives;

Whereas, to ensure proper accounting, transparent financial administration, and strict adherence to government auditing rules and regulations, it is necessary to maintain a dedicated depository account specifically for the collection and disbursement of said eco-tourism fees;

Whereas, the Landbank of the Philippines (LBP)-Iba Branch serves as an official government depository bank of the Municipal Government of Botolan, Zambales;

Now therefore, upon motion of Hon. Eddie D. Daos, seconded by Hon. Gregorio D. Jaring, and approved by all the members of the Sangguniang Bayan in session assembled, be it;

Resolved, as it is hereby resolved to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, and Ms. Mary Desilou M. Academia, Acting-Municipal Treasurer, to open a Special Account in the General Fund (SAGF) for eco-tourism fees at the Landbank of the Philippines-Iba branch, Iba, Zambales.

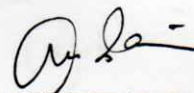

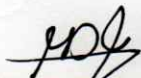

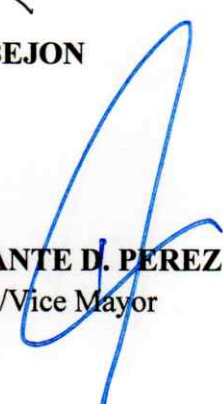
