RESOLUTION NO. 91-2026

RESOLUTION APPROVING THE ORDINANCE OF BARANGAY PORAC, ORDINANCE NO. 01-2026 ENTITLED “ISANG ORDINANSA NA NAGBABAWAL SA HINDI TAMANG PAGTATAPON NG MALANSANG TUBIG/MARUMING TUBIG SA PAMPUBLIKONG LUGAR AT NAGPAPATAW NG KAUKULANG PARUSA”

Whereas, Section 57 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that within ten (10) days after enactment, the Sangguniang Barangay shall furnish copies of all barangay ordinances to the Sangguniang Bayan concerned for review to determine whether the ordinance is consistent with law and municipal ordinances;

Whereas, the Barangay Council of Barangay Porac, Botolan, Zambales submitted to this August Body Barangay Ordinance No. 01-2026, entitled “ISANG ORDINANSA NA NAGBABAWAL SA HINDI TAMANG PAGTATAPON NG MALANSANG TUBIG/MARUMING TUBIG SA PAMPUBLIKONG LUGAR AT NAGPAPATAW NG KAUKULANG PARUSA”;

Whereas, after careful evaluation and review of the provisions of the subject Barangay Ordinance, found the same to be well within the legislative powers conferred upon the Sangguniang Barangay pursuant to Section 391 of R.A. 7160;

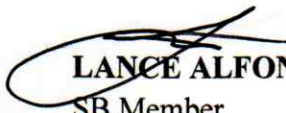

SERVICE AND MAINTENANCE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This memorandum of Agreement is entered into by and between the following:

DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL a government entity duly organized and existing under laws of the Republic of the Philippines, with office address at Botolan, Zambales, represented herein by the –Municipal Mayor, **HON. JUN OMAR C. EBDANE** herein referred to as the “**CLIENT**”;

AND

ARNULFO D. AUSTRIA**, herein referred to as the “**CONTRACTOR**”

WITNESSETH

WHEREAS, The **CLIENT** is the owner of various Medical Equipment, which is used by the **CLIENT** to provide medical service to its patients;

WHEREAS, the **CLIENT**, through its recognizes the need for a regular Inspection, Preventive Maintenance, Calibration scheduled for all its medical in order to ensure their proper and safe functioning;

WHEREAS, the **CONTRACTOR** is a private entity, who is engaged in Inspection, Preventive Maintenance and Calibration of Medical Equipment.

WHEREAS, the **CONTRACTOR** offered to provide the **CLIENT** its needed services, Inspection, Preventive Maintenance and Calibration for one (1) year.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree to enter into this Service and Maintenance Agreement with the following terms and conditions:

ARTICLE I. PERIOD OF CONTRACT:

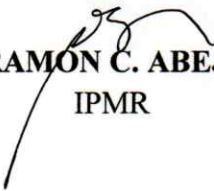
