RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PRESIDENT RAMON MAGSAYSAY MEMORIAL HOSPITAL FOR A RECIPROCAL REFERRAL ARRANGEMENT FOR THE PROVISION OF QUALITY, SAFE, AFFORDABLE AND EFFECTIVE POST-EXPOSURE PROPHYLAXIS SERVICES TO ANIMAL BITE PATIENTS

Whereas, the Municipality of Botolan recognizes the importance of providing accessible, timely, and appropriate medical services to its constituents, particularly to individuals who have sustained animal bites and require immediate post-exposure prophylaxis to prevent the occurrence of rabies;

Whereas, the Dr. Florentino C. Doble Memorial Hospital is committed to ensuring that animal bite patients within its jurisdiction receive appropriate medical assessment, treatment, and referral when specialized or additional prophylaxis services are necessary;

Whereas, the President Ramon Magsaysay Memorial Hospital is capable of providing the necessary prophylaxis services and other appropriate medical interventions to referred animal bite patients, consistent with applicable health standards and protocols;

Whereas, the DFCDMH and PRMMH are both operating an Animal Bite and Treatment Center and they desire to enlist the other as its referral facility to accommodate patients and provide them with accurate and reliable animal bite exposure management;

Whereas, there is a need to establish a formal referral arrangement between the Dr. Florentino C. Doble Memorial Hospital and the President Ramon Magsaysay Memorial Hospital to ensure the proper, timely, and coordinated provision of prophylaxis services to animal bite patients;

Whereas, the proposed Memorandum of Agreement shall define the respective roles, responsibilities, referral procedures, and other pertinent terms and conditions of the Municipality of Botolan, through the Dr. Florentino C. Doble Memorial Hospital, and the President Ramon Magsaysay Memorial Hospital in the delivery of such services;

Whereas, Section 22 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Local Chief Executive, in behalf of the Local Government Unit and subject to applicable laws, rules and regulations, shall be authorized to enter into contracts and undertake any obligation in behalf of the local government unit;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Doris D. Ladines, and approved by all the members of the Sangguniang Bayan in session assembled, be it;

Resolved, as it is hereby resolved to grant authority to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a Memorandum of Agreement with the President Ramon Magsaysay Memorial Hospital for a reciprocal referral arrangement for the provision of quality, safe, affordable, and effective post-exposure prophylaxis services to animal bite patients.

Resolved further, that copies of this resolution be furnished to concerned agencies, departments and offices for their information and appropriate action.

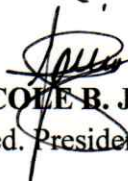

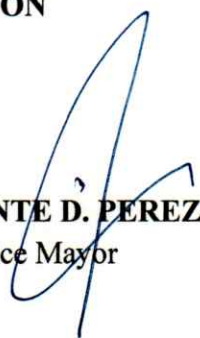
