**RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH SAN MIGUEL CORPORATION FOR THE IMPLEMENTATION OF THE ADOPT-A-RIVER PROGRAM IN THE MUNICIPALITY OF BOTOLAN, ZAMBALES**

**Whereas**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, and enhance the right of the people to a balanced ecology;

**Whereas**, the waterways within the Municipality of Botolan, Zambales are vital ecological and economic lifelines for the community, but are currently in critical need of massive improvements, intensive clean-up drives, and long-term rehabilitation to restore their natural state, manage siltation, and mitigate local flooding hazards;

**Whereas**, San Miguel Corporation (SMC), through its corporate social responsibility and environmental initiatives, has pioneered the Adopt-a-River Program, a collaborative project aimed at reviving major river systems and waterways through dredging, waste removal, and sustainable riverbed management;

**Whereas**, the partnership between the Municipal Government of Botolan and San Miguel Corporation will significantly accelerate the rehabilitation of local waterways utilizing SMC's technical expertise and heavy equipment resources, without imposing a heavy financial burden on the municipality's public funds;

**Whereas**, to formalize this public-private partnership and clearly define the duties and responsibilities of both parties, it is necessary that a Memorandum of Agreement (MOA) be executed;

**Now therefore**, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Eddie D. Daos, and approved by all the members in session assembled;

**Be it resolved, as it is hereby resolved**, to grant authority, as it hereby grants authority, to Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into and sign a Memorandum of Agreement with San Miguel Corporation for the implementation of the Adopt-a-River Program in the Municipality of Botolan, Zambales subject to existing quarry and dredging permits duly issued by the appropriate government authorities.

**Resolved further**, that copies of this resolution be furnished to San Miguel Corporation, and all other concerned departments and agencies for their information and appropriate action.
