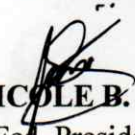

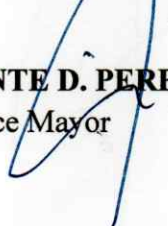

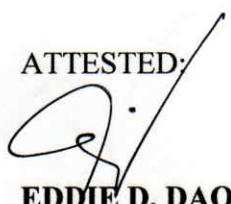
Resolved further, that a copy of this resolution be furnished to all concerned agencies for their information and appropriate action.

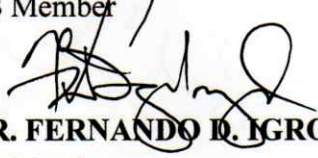

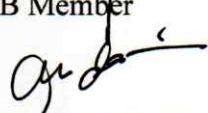

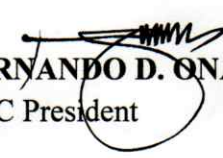
