RESOLUTION NO. 107-2026

RESOLUTION INTERPOSING NO OBJECTION TO THE CONSTRUCTION OF A BRIDGE IN PUROK 8, PANAN, BOTOLAN, ZAMBALES OWNED AND PROPOSED BY MR. ZALDY D. RAMOS, SUBJECT TO COMPLIANCE WITH EXISTING LAWS, RULES AND REGULATIONS

Whereas, a request was submitted to the Sangguniang Bayan Office by Mr. Zaldy D. Ramos seeking endorsement and interposing no objection for the construction of a bridge located at Purok 8, Barangay Panan, Botolan, Zambales;

Whereas, in support of the said request, Mr. Zaldy D. Ramos submitted a Deed of Donation in favor of Barangay Panan, stipulating that a property covered by Tax Declaration No. 012-1349, with a total of one meter, shall be utilized exclusively as a right-of-way for barangay Panan;

Whereas, Barangay Panan has favorably acted upon the request through Barangay Resolution No. 004-2022, titled "Resolution Approving Mr. Zaldy Ramos to Construct a Bridge Located at Purok 8, Panan, Botolan, Zambales";

Whereas, Mr. Ramos committed before the Sangguniang Bayan that he will donate the bridge to be used as right of way and that no fees shall be collected from the people who will pass through it;

Whereas, upon review and evaluation of the submitted documents, this August Body finds the proposed project beneficial for community access and connectivity, provided that all environmental, engineering, and legal standards are strictly observed;

Now therefore, upon motion of Hon. Doris D. Ladines, seconded by Hon. Gregorio D. Jaring, and approved by all the members of the Sangguniang Bayan in session assembled, be it;

Resolved, as it is hereby resolved to interpose no objection to the construction of a bridge in Purok 8, Panan, Botolan, Zambales, as requested by Mr. Zaldy D. Ramos subject to the following conditions:

1. Strict adherence to the terms and stipulations outlined in the Deed of Donation, particularly ensuring the property serves as a public right-of-way for Barangay Panan.
2. Compliance with all necessary permits, environmental clearances, and engineering safety standards required by national and local government agencies prior to and during construction.

Resolved further, that copies of this resolution be furnished to all concerned agencies for their information and appropriate action.

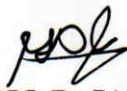

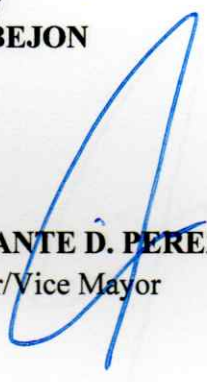

DEED OF DONATION

KNOW ALL MEN BY THESE PRESENTS:

This DONATION made and executed by and between;

CARMEN DIOROC RAMOS, widow; **PRIMA RAMOS-NACINO**, **MARIDIL RAMOS-TAYLOR**, **MARIJOY DIOROC RAMOS**, **NORMAN DIOROC RAMOS**, **ARNEY DIOROC RAMOS**, all represented by our Co-Heirs and Attorney-in-fact **ZALDY DIOROC RAMOS**, married to Cielito Bada-Ramos, by virtue of Special Power of Attorney under Doc. No. 434; Page No.88; Book No. XLII; Series of 2021 dated on February 09, 2021 Notarial Registry of Atty. Genaro N. Montefalcon at Iba Zambales and herein called the DONORS;

-IN FAVOR OF-

BARANGAY PANAN BOTOLAN, a government owned and controlled entry with office address at Barangay Panan, Botolan Zambales represented by its Barangay Captain **HON. ALBERTO VILORIA**, of legal age, married, Filipino citizen and with residence and postal address at Barangay Panan, Botolan Zambales, Zambales, herein called the DONEE:

WHEREAS, the DONORS are the registered owners of a parcel of land situated in Barangay Panan, Botolan, Zambales, more particularly described herein below:

TAX DECLARATION NO.012-1349

"A parcel of land, situated at Barrio Panan, Municipality of Botolan, Province of Zambales. Bounded on the North by Lot 521; on the South by Lot 518; on the East by Creek and on the West by West Philippines Sea containing an area of SEVEN THOUSAND TWO HUNDRED TWENTY-SEVEN (7,227) square meters, more or less".

WHEREAS, the DONOR are willing to donate the said portion of a parcel of land with an area of ONE (1) meters to the DONEE with the following conditions:

That said property with a total area of ONE (1) meter covered by Tax Declaration NO. 012-1349 shall be used as ROAD RIGHT OF WAY for Barangay Panan, Botolan Zambales for the welfare, benefits and convenience of its residents Except the Private Resort;

WHEREAS, the above described parcel of land is free from all liens and encumbrances whatsoever:

NOW THEREFORE, for and in consideration of my love and affection and other valuable considerations and services rendered in the past by the DONEE, by these presents, do hereby donate of the above described portion of a parcel of land with an area of ONE (1) meters, specified as Lot 4301 their heirs, assigns and successors;

That the DONEE, do hereby accept the same and hereby expresses their thanks for the generosity and kindness shown by the DONORS;

That for giving full effect to this donation, the DONOR have reserved other properties to maintain and support their station.

That I have duly complied with Article 1623 of the Civil Code prior to the execution of this sale while Act 3844 of the Land Reform Code is not applicable for reason that subject land is not tenanted and it is registered under Act 496 as amended.
