RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE TBEA SUBIC, INC. LOCATED AT SITIO PASAMBOT, SAN JUAN, BOTOLAN, ZAMBALES FOR THE PROVISION OF OUT-PATIENT, IN-PATIENT AND PREVENTIVE HEALTH CARE SERVICES TO THE EMPLOYEES OF THE SAID COMPANY

Whereas, TBEA Subic, Inc., an entity located at Sitio Pasambot, Barangay San Juan, Botolan, Zambales, requires the services of a duly licensed hospital equipped with adequate medical facilities and competent medical personnel to cater to the health care needs of its workforce;

Whereas, the Local Government Unit of Botolan operates Dr. Florentino C. Doble Memorial Hospital, a duly licensed health facility capable of providing comprehensive out-patient, in-patient, preventive health care, and basic dental services;

Whereas, ensuring access to quality health care for local workers promotes overall community wellness, occupational safety, and local economic stability;

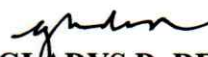

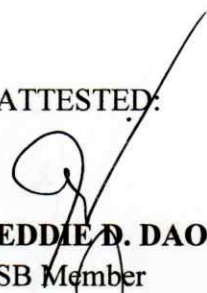
Resolved further, that copies of this resolution be furnished to all concerned agencies for their information and appropriate action.

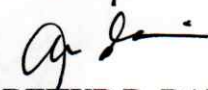

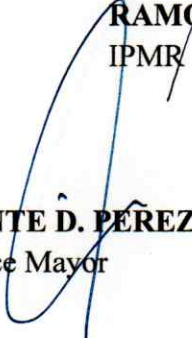

MEMORANDUM OF AGREEMENT

KNOW TO ALL MEN BY THESE PRESENTS:

This **MEMORANDUM OF AGREEMENT (MOA)** is made and entered into by and between:

TBEA SUBIC INC., a domestic corporation organized and existing under Philippine laws, with office address at Purok 1, Sitio Pasambot, San Juan, Botolan, Zambales, represented in this act by its Project Manager **Mr. Xu Ruwei** hereinafter referred to as the "**COMPANY**".

and

DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL, a licensed Infirmary under a Local Ordinance of the Municipality of Botolan, located at New Taugtog Resettlement Area, Botolan, Zambales, represented herein by its Municipal Mayor, **Hon. Jun Omar C. Ebdane**, hereinafter referred to as "**INFIRMARY**".

WITNESSETH THAT:

WHEREAS, the **COMPANY** is in need of a duly – licensed and operating hospital with adequate medical facilities and competent medical staff that will provide out-patient, in-patient, and preventive health care services to its employees, including basic dental dental services.

WHEREAS, the **INFIRMARY** is willing and has the facilities and professional staff to meet the requirements of the **COMPANY** subject to condition hereinafter stipulated;

NOW THEREFORE, for and in consideration of the foregoing premises and the mutual covenants hereinafter set forth, the Parties hereby agree on the following:

I. AFFILIATION REQUIREMENTS

The **COMPANY** is required to submit to the **INFIRMARY** the following documents: A complete list of employees, a list of authorized signatories, and a sample letter of authorization (LOA) indicating the limitations of the coverage desired by the **COMPANY** and the specimen signatures of the authorized signatories to issue the LOA. The **COMPANY** should update the **INFIRMARY** for any changes in its list of covered parties and list of authorized signatories.

II. COVERAGE

This agreement covers the following:

1. Emergency basic medical services which is available in the facility.
2. Medicines, laboratory procedures, and other medical procedures available in the hospital.

III. ADMISSION

In Emergency cases, a covered individual can only be admitted under the provisions of this agreement if he presents a valid Letter of Authorization (LOA) together with the **COMPANY** representative. The LOA is considered valid if it is signed by the authorized
