RESOLUTION NO. 103-2026

RESOLUTION GRANTING AUTHORITY TO HON. JUN OMAR C. EBDANE, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MDG DIALYSIS AND KIDNEY CARE SOLUTIONS, INC. FOR THE PROVISION OF EMERGENCY AMBULANCE CONDUCTION AND PATIENT TRANSFER SERVICES TO THE HEMODIALYSIS FACILITY LOCATED AT BARANGAY BATONLAPOC, BOTOLAN, ZAMBALES

Whereas, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates Local Government Units to promote the general welfare and ensure the delivery of basic health services to their constituents;

Whereas, the Local Government Unit of Botolan, Zambales, under the leadership of Municipal Mayor Hon. Jun Omar C. Ebdane, remains steadfast in its commitment to providing accessible, reliable, and high-quality healthcare and emergency response services to the public;

Whereas, MDG Dialysis and Kidney Care Solution, Inc. operates a hemodialysis facility located at Barangay Batonlapoc, Botolan, Zambales, catering to patient-citizens requiring specialized renal care and regular dialysis treatments;

Whereas, to ensure patient safety, timely medical intervention, and seamless transport during medical emergencies or critical care transfers between the hemodialysis facility and partner hospitals/medical centers, there is a vital need to establish a formal partnership for emergency ambulance conduction and patient transfer services;

Whereas, Section 444 (b)(1)(vi) of the Local Government Code provides that the Municipal Mayor shall represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations upon authority of the Sangguniang Bayan;

Whereas, after careful review and deliberation, the Sangguniang Bayan finds the proposed memorandum of agreement beneficial to the health and well-being of the residents of Botolan and neighboring areas;

Now therefore, upon motion of Hon. Dr. Fernando D. Igrobay, seconded by Hon. Eddie D. Daos, and approved by all the members of the Sangguniang Bayan in session assembled, be it;

Resolved, as it is hereby resolved to authorize Hon. Jun Omar C. Ebdane, Municipal Mayor, to enter into a Memorandum of Agreement with MDG Dialysis and Kidney Care Solutions, Inc. for the provision of emergency ambulance conduction and patient transfer services to the Hemodialysis Facility located at Barangay Batonlapoc, Botolan, Zambales.

Resolved further, that copies of this resolution be furnished to all concerned agencies for their information and appropriate action.

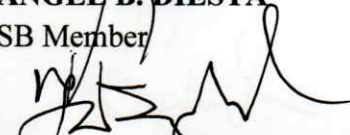

MEMORANDUM OF AGREEMENT

Emergency Ambulance Conduction and Patient Transfer Services

KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT is made and entered into this ____ day of _____ 2026 in _____, Philippines, by and between:

MDG DIALYSIS AND KIDNEY CARE SOLUTIONS INC., a duly organized free standing hemodialysis facility under Philippine laws, with principal address at 2904 Olongapo-Bugallon Road, Barangay Batonlapoc, Botolan, Zambales, herein represented by Bernadette E. Ordon, MD, Unit Medical Director, hereinafter referred to as the "FIRST PARTY";

-and-

DR. FLORENTINO C. DOBLE MEMORIAL HOSPITAL, a primary government hospital located at New Taugtog Resettlement Area, Botolan, Zambales, herein represented by its Municipal Mayor Honorable Jun Omar C. Ebdane and Chief of Hospital I, Peter Allen Sescon, MD, hereinafter referred to as the "SECOND PARTY".

WITNESSETH, THAT:

WHEREAS, the FIRST PARTY operates a free-standing hemodialysis unit and is required under applicable Department of Health (DOH), Philippine Society of Nephrology (PSN), and related regulatory standards to maintain referral and emergency transfer arrangements with a hospital for patients requiring urgent medical evaluation, stabilization, admission, or higher level of care;

WHEREAS, the SECOND PARTY maintains hospital and ambulance capabilities and agrees to provide ambulance transport support subject to availability and operational limitations;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Parties agree as follows:

1. PURPOSE

The SECOND PARTY shall provide emergency ambulance transport assistance to the FIRST PARTY for patients requiring

- a. Medical emergencies and dialysis related complications requiring urgent transfer
- b. Referral to higher-level facilities
- c. Situations requiring continuity of care under contingency issues

2. DESTINATION OF TRANSFER

Transfer may be made to:

- a. The SECOND PARTY, when appropriate for the patient's condition; or
- b. Another hospital in Botolan, Iba, or surrounding referral areas if higher-level care is clinically indicated.
